Subject: Implementation of Gazette notification dated 02.06.2023 — Reg.

Sir/Madam

In supersession of the earlier notifications of the Government of India, Ministry of Health and Family Welfare (Department of Health and Family Welfare) and on the basis of the recommendations of the Expert Committee constituted by Govt. of India and the Drugs Technical Advisory Board; and in exercise of powers conferred by section 26A of the Drugs and Cosmetics Act, 1940 (23 of 1940), the Central Government vide notification dated 02nd June, 2023 has prohibited the manufacture for sale, sale or distribution for human use of below mentioned drug fixed dose combinations with immediate effect (copy attached).
